2024 Youth Archery Camp

<u>Description</u>: This camp is designed for young adults interested in growing their skill set in archery hunting and camping. The camp is specific to males between 14-17 years of age who want to spend 4 days and 3 nights camping in the beautiful Black Hills at Pe'Sla. Campers will experience activities related to hunting game animals, such as deer, turkey, and elk. Activities will include but are not limited to; various archery shooting skills, scent control, tree stand safety, blind set-up, decoy set-up, tracking, calling, shot placement, and field dressing. There will also be exciting opportunities to swim and kayak at nearby Deerfield Lake and Recreation Area. We will be camping in wall tents. Cots and sleeping bags will be provided. Make sure to bring your pillow, toiletries, and extra blanket. **All archery equipment will be provided**.
