

**ROSEBUD SIOUX TRIBE
RESOLUTION NO. 2001-173
Amended February 16, 2016**

WHEREAS, the Rosebud Sioux Tribe is a federally recognized Indian tribe organized pursuant to the Indian Reorganization Act of 1934 and all pertinent amendments thereof; and

WHEREAS, the Rosebud Sioux Tribe is governed by a Tribal Council made up of elected representatives who act in accordance with the powers granted to it by its Constitution and By-Laws; and

WHEREAS, the Rosebud Sioux Tribe's Department of Natural Resources (DNR) manages, administers and controls all matters relating to the propagation, conservation management, distribution, transportation, storage and taking of fish and game and enforces the criminal and civil provisions of the RST Law and Order Code, subject to legislative oversight and supervision of the Rosebud Sioux Tribe Land and Natural Resources Committee; and

WHEREAS, Rosebud Sioux Tribe Resolution No. 2000-150 was duly enacted recommending all non-member hunters who harvest or attempt to harvest wildlife species on all trust land on the Rosebud Reservation be required to have a registered Rosebud Sioux Tribal Member Guide beginning January 1, 2001; and

WHEREAS, the Rosebud Sioux Tribe Department of Natural Resources recommends the following amendments to RST Resolution No. 00-150:

1. Any and all business licenses issued to non-tribal member individuals, partnerships, corporations, businesses and any other entity owned and operated by non-tribal members for the purpose of providing hunting and fishing guiding services on all trust lands on the Rosebud Sioux Reservation are hereby revoked and cancelled.
2. The following individuals are exempt from RST Resolution No. 00-150 requiring all non-members to hire registered Rosebud Sioux Tribal member guides:
 - a) Any individual who meets the requirements of holding the status of "affiliated tribal member" as outlined in RST Resolution No. 05-150 that can provide primary, continuous residency within the five county reservation area for minimum of one year.
 - I. Must provide proof of residency via SD State issued ID/license or voter registration.
 - b) Any individual purchasing a RST non-member or Affiliated Tribal Member fishing stamp and engaging in fishing only.

WHEREAS, the Rosebud Sioux Tribe Land and Natural Resources Committee recommends to the Rosebud Sioux Tribal Council adopt the amendments to RST Resolution No. 00-150; now


THEREFORE BE IT RESOLVED, that the Rosebud Sioux Tribal Council hereby adopts the amendments to RST Resolution No. 00-150.
