ROSEBUD SIOUX TRIBE RESOLUTION NO. 2005-150 Amended February 16, 2016

WHEREAS, the Rosebud Sioux Tribe is a federally recognized Indian tribe organized pursuant to the Indian Reorganization Act of 1934 and all pertinent amendments thereof; and

WHEREAS, the Rosebud Sioux Tribe is governed by a Tribal Council made up of elected representatives who act in accordance with the powers granted to it by its Constitution and By-Laws; and

WHEREAS, the Rosebud Sioux Tribe has enacted the Game, Fish and Parks Code, Title V, Chapter 35, Rosebud Indian Reservation for the management and control of the wildlife, fishery, forestry and outdoor recreation resources for the Rosebud Sioux Tribe; and

WHEREAS, the RST Department of Game, Fish and Parks manages, administers and controls all matters relating to the propagation, conservation management, distribution, transportation, storage and taking of fish and game and enforces the criminal and civil provisions of the RST Law & Order Code, subject to legislative oversight and supervision of the Rosebud Sioux Tribe Land and Natural Resources Committee; and

WHEREAS, the RST Department of Game, Fish and Parks recommends to the Land and Natural Resources Committee to approve the implementation of an Affiliated Tribal Member (ATM) licensing system; and

WHEREAS, the ATM licensing system will allow the selling of licenses/tags to Native Americans and other individuals that meet the requirements listed below, at discounted rates; and

WHEREAS, an ATM will be defined as an individual who meets one or more of the following:

- 1. An individual who owns RST trust lands.
- 2. A spouse of an enrolled RST member (with proof of enrollment and marriage certificate).
- 3. Parent of an enrolled RST member (with proof of enrollment and birth certificate of child).
- 4. Non-members who work for the Rosebud Sioux Tribe, Indian Health Services, Bureau of Indian Affairs, St. Francis Indian School or the Todd County School District.
- 5. Tribal member of another federally recognized tribe (with proof of enrollment).

WHEREAS, the Land and Natural Resources Committee concurs with the recommendation of the RST Department of Game, Fish and parks to approve the implementation of an affiliated tribal member (ATM) licensing system; and

WHEREAS, the Land and Natural Resources Committee recommends to the Rosebud Sioux Tribal Council to approve the implementation of an ATM licensing system; now

THEREFORE BE IT RESOLVED, that the Rosebud Sioux Tribal Council hereby adopts and approves the implementation of an Affiliated Tribal Member licensing system.
